- ☀ Vendor booths available: 10 x 10 - \$80.00 or 10 x 20 - \$145.00
- ☀ Vendors to be completely set up before 8:30 am, will need to supply their own tents, & tables. No power is available as this event is in a field. Tents are not required, just suggested.
- ☀ Vendors will be allowed to pull up to their booth space, QUICKLY unload, move their vehicles to the designated vendor parking area and then set up – no vehicles are to block the booth lanes.
- ☀ Vendors are not required to be licensed, but will need to pay their own State Tax if applicable.
- ☀ Vendors will need to sign a Hold Harmless Agreement with Vintage Gardens/Tarrie Miller for any event liability issues.
- ☀ Vendors & shoppers will have 4 acres of parking in adjoining farm in addition to Vintage Gardens parking. Area directly in front of the barn is for shopper merchandise pick up only.
- ☀ Restrooms, trash cans, & WIFI connection available. Local High School team will provide shopper hauling and merchandise holding services for a donation fee.
- ☀ There will be a Coffee & Cookies refreshment food stand & Folk Music playing in the venue.

## **As a Vendor, I hereby agree to the following terms and conditions:**

To provide my own tent(s) with **required** safety staking, tie downs, or leg weights to prevent my tent from blowing away & causing injury to any shoppers or other vendor's merchandise.

To provide my own displays, tables or stands and that all of my displays will be sturdy and safely constructed and will not exceed 6' (feet) in height as not to cause injury to any shoppers or other vendor's merchandise.

I agree to set up my booth prior to 8:30 am and to remove my vehicle from the vendor sales area prior to 8:30 am.

I agree to pull my vehicle up to my assigned booth space, QUICKLY unload my merchandise and then move my vehicle to the designated Vendor parking area, **before setting up my booth**. I agree not to block the booth lanes from other vendors.

I agree not to pack up/break down my booth prior to 5pm – regardless if I sale out of merchandise.

I agree to remove all of my merchandise packing materials and/or trash from my booth and not to leave behind any liter.

I agree not to have any open flame items or any materials that can cause a fire. I agree not to smoke in the vendor field but only at the designated smoking area located next to the restrooms.

I agree not to bring any animals, hazardous materials, firearms, weapons, or any inappropriate displays as this is a family events.
